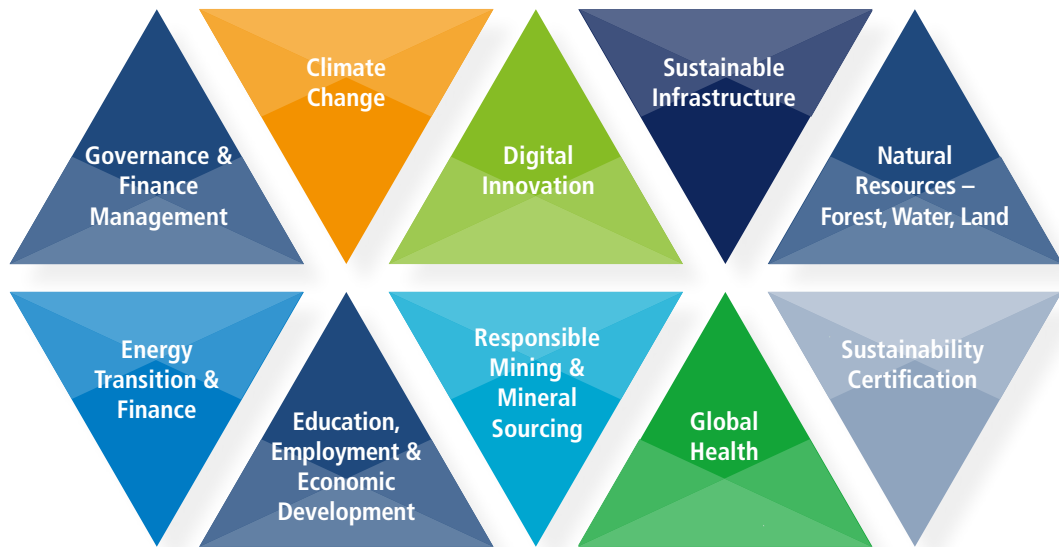

GFA HISTORY

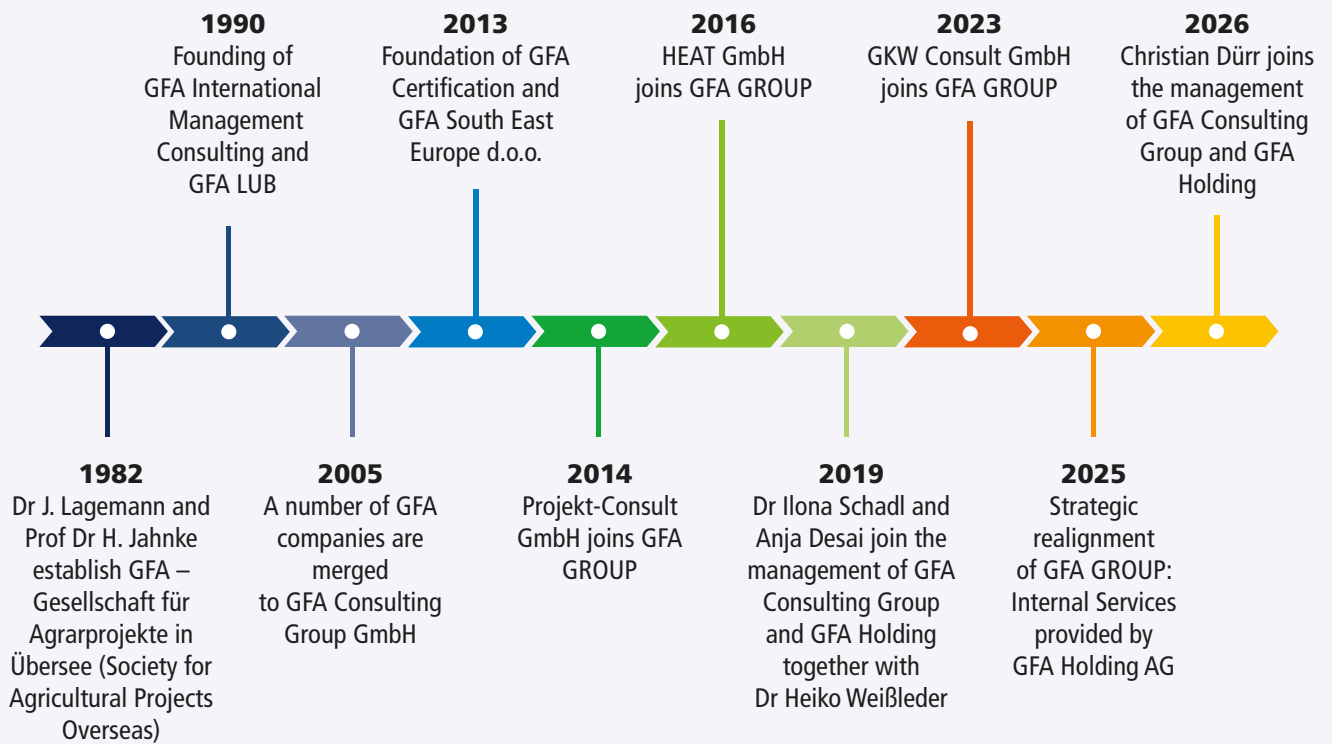
